Special Investment Categories

Banks & Financial Institutions - Based on \$25 per million dollars in deposits in Leavenworth/Lansing, \$1,000 min., \$2,500 max. Branches may be added for \$295 each. All assets combined.

Utility Companies - Base rate \$750

Hospitals, Hotels/Motels, Apartments - Base rate plus \$1 per room or unit

Church or Civic Organizations - \$175

Individuals - \$125 (can have NO business affiliation)

Multiple locations of same business with same owner -

All employees at all locations must be combined for employee count. Each additional location listed would be \$150.

***Professionals** - \$255 Category would include real estate and insurance agents, financial advisors, dentists, doctors, attorneys or accountants. You can join as an individual or under the company by number of employees plus \$125 for each additional participating associate.
